1. Apologies - None received

2. Minutes of Previous meeting

The Minutes of the meeting held on 20 August 2025 were discussed and approved. Mr Miles, Vice Chairman signed the Minutes as a true record, as Mrs Cox was not at the previous meeting.

3. Matters Arising

- 3.1.A list was received from the Treasury of zero-rated properties and those receiving a 15% discount. The zero rating of properties were due to properties in an extremely bad state or needing renovation. The properties receiving a 15% discount are all on the Crosby Meadows Estate, however Mr Lovelady informed the Commissioners that the properties in question were finished and the roads tarmacked in 2023, so they should be paying full rates. Clerk to follow up.
- 3.2. There was discussion regarding hedge trimming and the notice to be put in the paper. DoI has since put out a press release regarding trimming trees, so reference needs to be made to this. Clerk to circulate revised notice.
- 3.3.Relating to this, if DoI says a tree needs to be removed, then you need to apply to DEFA for a licence, but if DEFA refuses then it needs to be put in writing to DEFA that it had been requested by DoI and so the responsibility now lies with DEFA.
- 3.4.In respect of trees at Ballagarey that are maintained by the Commissioners but are on land owned by Dandara, the Clerk requested a licence from DEFA to remove the trees but they refused as Dandara need to complete the form because they own the trees. Clerk to pursue.

This matter was discussed as a Statement of Case must be submitted prior to the Appeal Hearing.
