1. Apologies

None

2. Conflicts of Interest

The Chairman read the agreed text - there were no declarations of interest.

3. Visitors

3.1. Juan Turner, Marown resident and Energy FM owner, Denise Collister and Marilyn Corteen, Marown residents

There was a discussion regarding the increase in rates for Marown for the 2025/26 year; it was explained that the increase was necessary due to increases in the costs of the services the Commissioners provide – amenity site, waste disposal, contractors etc; for two years the Commissioners didn't increase rates and used reserves; other Local Authorities have bigger reserves so didn't need to increase; other authorities have more commercial rates – Marown only has the Co-op; when we go into Douglas we pay to park and use their shops which gives Douglas more money; Commissioners are all residents and so have to pay the increase too; it's annoying that some people in the parish haven't paid their rates but still get the same service – the bins have to continue to be collected for health and safety reasons – the Commissioners will be putting pressure on the Rates Section of Government to pursue the outstanding rates; Local Authorities are pushing back at Government who are passing costs on / increasing costs at the amenity sites and trying to get Local Authorities to take on more. It was raised that the Swimming Pool made £35k profit and has over £200k in reserves – Mrs Cox explained that those sums are allocated to pay for the replacement of the lighting, roof repairs and major refurbishment of the changing rooms. In addition costs have increased for heating, lighting, chlorine etc.

The visitors raised the issue of overgrown hedges which are a concern – the Commissioners explained that they will be sending out letters to properties with overgrown hedges requiring them to trim them.

3.2. Alan Hardinge, Dol, Sgt Lee Wright, Roads Policing and Sgt Scott Fielding, Peel Sergeant

There was a discussion regarding the parking along Old Church Road, particularly during TT and Manx Grand Prix. Sgt Wright said the problem arises as many people park there to watch the races at Crosby, along with people going to the Playing fields, the nursery, Costa and also the residents of Crosby Meadows park there so they can get out when the roads are closed. People also park inconsiderately and you can get cars coming to a standstill. Sgt Wright suggested that the Playing Fields could drop their bollards and allow people with permits to park there – apparently they have previously been asked and will only allow it for their members. Mr Hardinge said that he'd be happy to allow Crosby Meadows residents to park at the DoI Ellerslie depot in the evenings and at weekends – on a permit basis – Mr Lovelady will speak to the residents.

A 30 minute parking limit was suggested along Old Church Road.

Another issue is that the Police put cones on the hill leading down to Old Church Road but people move the cones to park! It was agreed that there should be double yellow lines on both sides of the road and no parking at all (the Isle of Man does not have legislation for red lines).

Sgt Wright and Mr Hardinge will take these matters back to the TT committee.

Mr Lovelady owns some land next to Ellerslie depot and he suggested he could apply for planning permission for parking for 25-30 cars – it would be free and on a first come first served basis – Sgt Wright thought this was a good idea to help alleviate parking issues. The Commissioners also support this proposal, subject to Planning Approval.

There has also been a problem with vehicles being left on Old Church Road. People who live elsewhere park their vans there and some vehicles have been abandoned - Sgt Wright said if they have no tax the Police can remove the vehicles.

8.7. Local Government Amendment Bill

- There was much concern about the proposed clauses to this Bill which seem to allow the imposition of new functions on Local Authorities or that they would have to make a financial contribution to someone else performing that function. There has been no consultation on this or offer of extra money to carry out any new functions. It appears to be a backdoor to increasing rates and keeping taxes down. This erodes the powers of Commissioners. Marown Commissioners do not accept this as they were not consulted and they have already had to increase the rates as Government has increased charges for waste disposal etc and this would impose more on them which would have to be passed on to the ratepayers. Clerk to send letter, voicing the Commissioners' opposition, to Chris Thomas, MHK and local MHKs.
